


HOW MANY ARE WE?


WE ARE IN THE MIDST OF A 911 Civil Rights Assault On Our Republic

- We propose the creation of an uncensored Centralized Virtual Town Hall Meeting Pipeline. This will provide Americans with a sharable step-by-step vehicle. Held in any informal neighborhood venue; American Legion halls, Fire Departments, local pub's, Community Centers, Church halls or even in someone's backyard. The meetings are designed to present pre-taped speaker-presenters and resources. President Trump can transmit messages directly to voting blue-collar American men, women and minorities. These Americans are ignored in polls. They are the backbone of America... small business owners, clerks, servers, cooks, mechanics, farmers', construction, and assembly line workers. Many do not access social media. This is how they can be reached.
- Communication is paramount in finally 'unifying' the American groups; alliances, coalitions, clubs, and podcasters by bringing them under one massive umbrella with the use of a Trump App.
- We have since learned Dr. Rick Bright ordered the production of Remdesivir before the first case of Covid was diagnosed in the US and against WHO's recommendation. President Trump supported the vaccine. We believe his decisions were based on what was assumed at the time as the best experts advising him. These so-called experts lied to an entire nation and to a sitting president. We, *the 42+million* will make a powerful difference in the next election. We ask President Trump to listen to what we have to say and to include us in his campaign efforts.
- Medical freedom will make a decisive difference in our lives if the president addresses these issues. We believe he will lose the independent vote hands down if he does not. The risk of ignoring our massive constituency directly affected by ineffective vaccines and CDC Death Protocol deaths from Remdesivir and other deadly drugs will undermine any candidate's primary election.

THE GOAL IS FOR DONALD J TRUMP TO WIN

To restore medical freedom and “right our Republic’s ship” with Voter Integrity.

- We ask him to restore Law & Order, our Medical Freedom, and Voter Integrity.
- We encourage him to team up with and capture the Doctor, Legal, and Strategic Influencers with their millions of followers. To propose and create a Trump Medicus~Advisory Board. Hold a small public *Trump Medical Freedom Roundtable Discussion*. Invite 4-5 of the influencers (*Dr. David Martin, Dr. Peter McCullough, Dr. Richard Amerling*). It would underscore President Trump’s intentions to all of us.
- We are a constituency that has not been heard... this is the primary goal of this meeting. We are the *Trump Card*, an unexpected massive constituency. We make our decision NOT on what party to vote for, but on who will restore our medical freedom. If not addressed, then these votes will most likely go to Robert Kennedy Jr., who has established the Children’s Health Defense Chapters in 15 states. These will most be used to influence voters.
- Appoint an independent Special Master in each state to investigate and prosecute offenders; the Fauci Mob, CDC, FDA, NIH, HCA, HIS-*EHR & EMR*, DHHS, NBPAS, ABPSUS, AAPS, ACS, ABMS, CEPI, ACH, AHCA, CMS.
- Propose a massive overhaul of the American Healthcare System.
- **Stop ALL perverse CMS-generated incentives** – two acts that pulled the strings of hospitals during the pandemic. The PREP Act shielded them from any liability when using “only approved measures” to care for Covid patients. The CARES Act paid them AT HIGHER RATES for using those measures on Covid patients as with the AI GPT (*Generative Pre-trained Transformer*) AI Chat Bots - will decide who lives and who dies! This Act *Incentivized*: (1) categorized as many patients as possible as COVID; (2) isolate them from family; (3) kept them on multiple doses of *Remdesivir (ask Cooki Mariotti, about the 45 doses given to her husband)* patients kept on and vents for as long as possible; (4) issues categorized as Covid complications because the treatment of those was covered at higher hospital rates.
- STOP the Emergency Use Authorization (EUA) *Remdesivir and other deadly drugs* which continued to be administered upon arrival in hospital ERs. Once the EUA is stopped, we will have access to Ivermectin and Hydroxychloroquine... it’s cheap - costs pennies to produce and it WORKS.

CONTINUED...

- Propose to REPEAL - and **KILL** the CDC Death Protocol / Immunity Law, Guardianship, and Free-Kill Laws and hold perpetrators accountable. We have lists of laws requiring immediate retooling.
- Propose to STOP the persecution of doctors, nurses, non compliant military, and pilots, etc. And restore their rights and pensions.
- Propose to make medical records easily accessible and free to surviving families of those killed.
- Propose Statutes of Limitations on Pandemic Deaths, Vax-injured, Guardianship Law, and Free-Kills to become 'Unlimited'.
- Propose that you recruit legions of qualified forensic medical records readers for Pandemic Deaths, Free-Kills and Guardianship Law casualties.
- Propose to liberate early treatment life-saving drugs and make them easily available and affordable as with Ivermectin & Hydroxychloroquine, and Monoclonal Antibodies treatments.
- **Propose “Made In America Drugs”**
